

Britain is an ideal country for criminals!

How and on what can you earn decent money in London? Naturally, the amount must be large enough to justify the risk.

I have no doubt that any British person will answer without hesitation that these are documents that can be sold to an illegal immigrant. Of course, the greater the volume and quality, the more money you can get.

And here, for criminals, an option is provided:

A passport and an official residence status in the country. The bank account and apartment are registered in the name of this person.

It is she, Rahel Moges, who is my assistant and friend.

My assistant Rahel had a stomach cramp at the end of December last year. But as the next day she only remembered the fact, but not the details, we immediately agreed to go to the doctor together. However, she was flying to Ethiopia for two months to see her family. So we postponed the visit to the doctor until she returned to London.

She returned on March 6 and was at my house on the evening of March 11. She said that she haven't found a job yet. And with nothing wrong with her stomach if she did not eat anything. This is, of course, bad, because a person cannot not eat.

We agreed to go to the doctor tomorrow, March 12, after the visit of a council worker, who was supposed to check the condition of the apartment. However, the council worker rescheduled the visit for 4:00 p.m., so the Rahel wrote that she would not be able to come today and promised to come tomorrow, March 13.

However, on March 13 she did not come and contact with her by phone was lost. My assistant Rahel disappeared.

mind would never write the word PLEASE in such a simple sentence. It was after this SMS that I realized that there was a man in her apartment who did not let her finish. And she wanted to write PLEASE HELP

Without knowing Rahel, any person after reading this will think: so what's so criminal about it - a man and a woman stayed overnight.

However, I can confidently say NOT WITH RAHEL. Because as far as I know Rahel, she will not enter into sexual relations on the first day of meeting.

And last year Rahel had a very unsuccessful relationship with a man, but it ended without any problems. That is why she told me that she does not want to see men in her apartment, even me. And that is why she did not give me her address.

In addition, not a single woman IN THE WORLD, if everything is fine, will try to write HELP ME.

What could the criminal do to achieve his goal.

This case should be classified as FORCED SEX USING OFFICIAL POSITION!

In addition, Rahel, I know this for sure, is a strong woman and one man cannot cope with her, therefore GROUP RAPE happened. It is quite possible that more than three men took part in this. In order for the rape to continue as long as possible that night and the following days. The goal is to turn Rahel into a prostitute as quickly as possible.

Of course, in this case, it was not without drugs, because in a normal state, any person, every time, will resist what he does not want.

And after a week of daily violence and drugs, it seems to me that any woman should break down and accept the inevitability of becoming a prostitute. And, of course, to end this horror of bullying, she agreed to answer the phone as required of her.

The goal of the criminals was to turn Rahel into a prostitute, and then sell her to a brothel.

For example, a criminal case in this case was initiated on March 15. And on March 20, it was closed due to the lack of evidence of a crime.

On March 15, Rahel was not yet ready to answer the phone the way a criminal needs to. That's why the police couldn't get through.

And by March 20, Rahel was taught to answer correctly, under the threat of physical violence, which, for training, was used repeatedly.

Thus, the police managed to get through and get an answer that Rahel was fine, she was alive and well, living with a friend and enjoying life.

After that London police didn't even have the desire to respond to all the statements. Therefore, the logic of the police is striking in its naivety and incompetence. Namely:

Firstly, because an employee of the council cannot be a criminal. And this is the biggest shame and scandal in the UK Because the main organizer of the crime is a representative of the administration of one of the London districts. **I know who he is and I can prove it!**

And secondly, Rahel is an adult woman and she can choose who to communicate with. Now she doesn't want to communicate with you and no one can force her to do so.

And where she lives is also her business. Wants to live in a brothel, let him live there.

In fact, the police helped the criminals hide the crime

And the criminal, with impunity, got what he wanted!

Now about our communication on the phone Rahel

I have two phone numbers and two phones. But no one answers my call. This means that it is forbidden to talk to the person who was supposed to remind and take Rachel to the hospital. Rachel also does not have the opportunity to move freely around the city to visit a doctor.

This can only mean that Rachel is in a closed room and under very strict control. And naturally, she did not come here of her own free will. This means that Rachel was kidnapped.

However, according to the police, Rachel answers all questions correctly. And this is an indication that Rachel has undergone training, like all sex slaves.

Now we have a kidnapped woman with the status of a sex slave.

Now we can't know how free she is in the messages that are sent on her behalf. Sometimes someone writes to me and I can send messages. The most striking proof that Rachel herself cannot read and answer my messages was my birthday greeting. On the second phone:

[24.04, 0:12] bdraguns: Today is your birthday. You've become quite an adult, you're in your third decade. I'm really sorry that I can't congratulate you properly. Hug you tight and kiss you. I know you've always been against kissing. But it can be done once a year. I'm sure you'd let me kiss you this year. Or maybe you even wanted to do it yourself.

She replied very modestly. Literally: **Thanks for your thoughtful wishes.**

[24.04, 12:39] bdraguns: I must admit, I wanted to give you this for your birthday. You've seen them before. But I don't like to give gifts for no reason. Now you will have to wait, but I promise, as soon as I see you, alive, you will definitely receive this gift. (I sent her a photo the big gold earrings that I bought back in the summer, last year, and which she had seen.)

[24.04, 14:40] bdraguns: I remember you saying that I am your only friend in this country.

Think about it, would you write something in response to such messages?

But Rahel didn't answer!

Results of the investigation: Where could an unemployed, kidnapped woman be since March 12 (more than two months), under very strict control and in the status of a sex slave, who does not even have access to messages on her phone?

The answer is definitely, only in a brothel

In conclusion, about Rahel herself and my relationship with her.

Rahel Moges 24/04/1994 Orthodox African, citizen of Eritrea. My assistant and friend. She studied architecture for two years. She studied well, so she did it for free. But sometimes she had to pay for her studies. For example, at the end of 2023. Then she managed to save up the required amount. And in the spring of 2024, she failed. That's why she interrupted her studies, but promised me she would be reinstated at the same faculty in September 2025.

What is my relationship with Rahel. I'm 71 years old and have prostatitis ten years, so it doesn't make sense to talk about sexual relations. I can call Rahel my assistant and friend.

We met in 2023, when we lived in the same house in neighboring rooms. At that time, I was working on the documents for filing a patent application. Rahel helped me with the drawings and the documents themselves. I have received a patent for this invention. Then I submitted another application, but it was not recognized as an invention. At the end of 2024, I applied for another patent. Now I have started to assemble a new design, and when I finish it and test it, I will apply for a patent again.

Of course, Rahel participated in all my projects. Besides, she's been helping me with the cleaning all this time. Sometimes she cooked and it was always very tasty.

I have a very good relationship with Rahel. I would call them friendship. And Rahel, she once told me that I was her only true friend in this country. That's why when Rahel wanted to see her family, whom she hadn't seen in six years, I bought her plane tickets. However, it is not very expensive, only about 575 pounds.

And in the future I intend to help Rahel in every way possible, because she is a very valuable assistant for me.
